# MEMBERSHIP APPLICATION AGREEMENT

I agree to all conditions of participation membership listed in this membership application agreement. I understand that violation of any item may lead to referral to the Managing Member of PTP, resulting in a warning or the possibility of termination of my participation membership.

1. I will obey all directives of the Rangemaster or staff.
2. I will abide by all rules posted by PTP.
3. I will handle firearms and other equipment safely at all times.
4. My behavior at PTP facilities will be courteous and non-confrontational.
5. I will conduct myself in accordance with good sportsmanship at all times.
6. I shall obtain the prior written approval from PTP's Managing Member before I bring any non-member or other guest to any PTP facility or property.
7. I consent to a background check and fingerprinting, if necessary and at the sole discretion of PTP.
8. I shall not introduce illegal firearms or ammunition into any PTP facility, property or event.
9. I understand that, if approved, my participation membership does not confer any rights to me to hunt, harvest and/or trespass on any property owned by PTP.

As a participating member, I accept the following responsibilities:

1. Not to act in any way that brings harm to myself, other participating members or PTP.

6. I understand and accept that no still or video cameras are permitted on the range without the express written permission of the Managing Member of PTP.

I hereby waive any claim against PTP and/or their staff, management, Managing Members, Members, volunteers and/or agents, both as individuals and as limited liability company representatives (collectively referred to as “Operator(s) and/or their Representatives”), from and against any and/or all loss, liability, claim, expense, costs, suits and/or damages of any kind, nature and/or description resulting directly or indirectly from my use of PTP’s facilities, my presence or participation at PTP’s facilities and/or sponsored public activities, matches or events and any issues pertaining to paid or volunteer work or any interactions with the Operator(s) and/or their Representatives which may arise out of activities or conduct at any PTP facility. I further assume all risks inherent in my presence at or participation in activities at said PTP facilities, and release the Operator(s) and/or their Representatives for all liabilities which arise. I further agree that any disputes unresolved by negotiation must go to Mediation before resorting to final and binding Arbitration, utilizing mediation rules and arbitration rules of the American Arbitration association, and to reimburse the Operator(s) and/or their Representatives for all attorney fees, costs and/or expenses related to any and all unsuccessful dispute resolution that I initiate and/or am a party to against the Operator(s) and/or their Representatives.

# Range Rules

## General Rules

- ALWAYS keep the gun pointed in a safe direction
- ALWAYS keep your finger off the trigger until ready to fire
- ALWAYS keep the gun unloaded until ready to use

## Practical Tactical Plus Range Rules

- Range Staff have the right to inspect all firearms, ammunition, and equipment
- All handguns up to and including a .45 Long Colt are permitted
- All rifle calibers up to and including .30 caliber are permitted
- Load and unload firearms only on the firing line
- All firearms must be cleared, breach open, and properly cased when removed from the firing line
- Shooters must wear eye and ear protection prior to entering the range and keep it on until they exit
- If any malfunction occurs, and you cannot clear the problem, leave the firearm on the bench and ask a Range Officer for assistance
- Handling a firearm behind the range line is prohibited
- No drawing and/or firing from a holster
- No shooting at objects on the floor, walls, or ceiling
- Cross lane fire is strictly prohibited
- If a cease fire is called, unload your firearm, lock the breach open, and step behind the range line
- No one is allowed forward of the firing line at any time
- Only one loaded firearm at a time
- Use the correct ammunition for your gun
- Tracers, explosives, steel case, steel core, or armor piercing ammunition is strictly prohibited
- No black powder firearms allowed
- Use only approved targets
- Never use alcohol before or during shooting
- Shooters must be 18 or older to shoot alone
- If you intend to do bodily harm to yourself or others, you are not permitted on the range
- Be courteous and aware of the other shooters around you
- Notify a Range Officer on any unsafe practices on the range
- No pregnant women allowed on the range at any time
- Food and drinks are not permitted on the range
- Practical Tactical Plus LLC reserves the right to refuse the use of the range or services to any person for any reason.

Practical Tactical Plus LLC has added new measures to ensure the safety of all customers and employees while using the facility. This memorandum of understanding is to reiterate the standing safety rules and help all customers understand the new safety rules being implemented at Practical Tactical Plus. Please acknowledge each rule by placing a checkmark in the box next to each rule. If you have questions or need clarification on any point, please ask an employee. We are happy to help!

### Universal Firearm Safety Rules

- Treat every firearm as if it were loaded **AT ALL TIMES.**
- NEVER** point at anything you are not willing to destroy.
- Keep your finger **OFF** the trigger until your sights are aligned and you are ready to fire.
- Know your target and what is beyond your target.

### Entering the Facility

- Firearms will be unloaded.
- Magazines will be empty.
- Upon inspection of firearms, chamber flags will be provided for each firearm at no cost.
- Firearms preferably in a case, bag, or box.
- If no case, bag, or box is available action will be open and magazine removed, and the firearm will be oriented toward the floor.
- Firearms not in a case, bag, or box will be visible at all times.

### On the Range

- Behind the Firing Line
  - NO LIVE FIREARMS BEHIND THE FIRING LINE AT ANY TIME.**
  - NO HANDLING OF FIREARMS BEHIND THE FIRING LINE.**
  - A chamber flag will be inserted in all firearms behind the firing line.
  - Magazines will be removed from firearms behind the firing line at all times.
  - No loaded magazines behind the firing line.
  - All other firearms are to be kept cased and/or with chamber flag inserted and magazine out.
  - Behind the firing line, there are two safe directions: the floor and the back wall.
- On the Firing Line
  - One firearm per lane at a time.
  - Filling magazines will only be performed at the firing line.
  - The only safe direction at the firing line is **DOWNRANGE.**
  - If you are unfamiliar or uncomfortable with a firearm, ask an employee for assistance.
  - If there is a malfunction that you are unable to clear, set the firearm on the firing bench pointed down range and ask an employee for assistance.
- Transporting Firearms to and from the Firing Line
  - Before any firearm is moved from the case, a chamber flag will be inserted, and the magazine will be removed.
  - FIREARMS WILL BE ORIENTED TOWARD THE FLOOR UNTIL ON THE FIRING LINE.**
  - Before any firearm leaves the firing line, a chamber flag will be inserted, and the magazine will be removed.
